The District’s aquatic programs include all organized activities that use the District pools and trips organized for the swim teams, to include, but not limited to swim meets. Participants can feel confident that our aquatic staff is highly trained and qualified to handle any and all emergencies that may arise. Of course, students are exposed to open water and the possibility, though exceedingly remote, of drowning, does exist. When safety rules are not observed or students are not attentive, wet decks and uneven concrete deck surfaces do cause stubbed toes, tripping, slipping and falling. In extreme circumstances, it is possible that broken bones and trauma to joints and head may result. Bee stings are another routine hazard of which participants need to be aware. In some classes students will be exposed to the diving board. These, as are all activities, are well supervised. However accidents with diving boards do occur. Serious injury may result including fractures and trauma to the head and spine.

Agreement, Waiver and Release – Aquatic Programs

In consideration of being permitted by the above, Cordova Recreation and Park District, to participate in the above program, I hereby waive, release and discharge any and all claims for personal injury, death or property damage which I may have or which may hereafter accrue to me as a result of my participation in said activity. This release is intended to discharge in advance the above District, other participants, coaches, instructors, officials, sponsors, advertisers, owners and leasees of the premises used to conduct the event and each of them, their officers, directors, agents, all of which are referred to as “Releasees”, from any and all liability arising out of or connected in anyway with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above person or entities free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in said activity.
